



Terms and Conditions of OSW Generic Loan Promotion ("Promotion Offer")

- The Promotion Offer is open to Overseas Workers in Hong Kong ("OSW") who have been approved a personal loan with any of the following product codes: 899, 900, 905 & 910 ("Personal Loan").
- The Promotion Period is from January 1 to December 31, 2018 ("Promotion Period") and Redemption Period is based on the loan activation date ("Redemption Period"), as follows:
